# CRDF GLOBAL REQUEST FOR PROPOSALS (RFP)

**Data Analysts for MOSAIC Counterproliferation Data Integration Project** 

#### **Summary:**

CRDF Global is seeking data analyst(s) with experience cleaning and working with large diverse data sets, familiarity with financial and foreign entities, and knowledge of weapons of mass destruction (WMD) networks and sanctions evasions techniques. The data analyst(s) will access and analyze data collected from various partnered implementing organizations and other open-source origins as well as importing data from larger databases on a regular basis using the top tier of the IBM Analyst's Notebook software provided by CRDF Global. The resulting analysis will support CRDF Global and its partner's Financial Chilling Action Plan (FCAP) and Russia Chemical Biological Threats (R-CBT) programming by producing impactful data products, identifying trends, and supporting more accurate stakeholder targeting among the financial, logistics, government, and technical sectors worldwide to improve intervention in proliferation networks. Analysis will draw from and support the MOSIAC (Multi Open-Source Analysis & Information Catalog) initiative.

## Scope:

Using software sourced by CRDF Global, the data analyst(s) will perform periodic analytical reviews and produce reports on trends and findings based on data that CRDF Global and the analyst have acquired. The analyst will establish either monthly or quarterly briefings for analysis reporting that will be held through briefings for the funder, CRDF Global team, and other partnered implementors. Together, these actions will seek to provide a comprehensive picture of Advanced Conventional Weapons (ACW), Russian, and PRC proliferation threats. Potential outputs of interest include analytical insights into trade data, designations, banks engaging with adversary defense sectors, sanctions calibration, lead generation, and case studies. Data is sourced from a diverse array of implementer projects focused on Russia and China related counterproliferation, advanced conventional weapons, chemical and biological threats, and general sanctions topics. The data analyst(s) will work in conjunction with a separate data engineer (responsible for data migration from those sources) to develop and further expand a single, multi-dataset virtual environment Additional data will be provided by CRDF Global as it is generated, requiring occasional new analysis for the continuously data-fed project.

This project will enable integration and analysis of existing and future data to provide CRDF Global and implementing organizations with a more intersectional view of threat related data, bolstering the ability of CRDF Global and fellow implementing organizations to deliver data-informed programming while providing relevant data products to keys stakeholders.

## **Tasks and Deliverables:**

CRDF Global is seeking data analyst(s) who can implement the entire scope of this request based on proven capabilities and past experience. CRDF will consider proposals from both individuals and teams which can support the following tasks and deliverables:

- Create a checklist of deliverables and dependencies related to the project scope;
- 2) Conduct thorough analytical review of initial data, totaling approximately 100 pdfs, provided by the funder and partnered implementers;
- 3) Deliver either monthly or quarterly live briefings\* (virtual or in-person at CTR's discretion) on trends and analysis related to ACW, Russian, and PRC proliferation threats to CRDF Global and select implementor audiences over a nine-month period;
- 4) Participate in intake and conduct of new analysis of additional data as needed for this continuously data-fed project (preferably, data analyst will be able to suggest and source additional open-source info for platform);
- 5) Submit After-Action Reports for each briefing which summarize observations, successes, lessons learned, and recommendations for future programming based on the briefings.
- \* **Note:** CRDF Global would request that proposals include alternate cost estimates for both a <u>monthly</u> and a <u>quarterly</u> live briefings option.

## **Preferred Contractor Requirements:**

- 1) At least five (5) years of relevant experience cleaning data, conducting analysis, and/or delivering briefings related to international finances or counterproliferation.
- 2) Knowledge of all or many of the following subject matter areas:
  - A background in using analytical software such as IBM Security i2 Analyst's Notebook to clean and analyze large data sets.
  - Experience delivering briefings using PowerPoint and/or analytical dashboards such as Tableau or Microsoft Power BI.
  - Methods the Russian and Chinese defense sectors use to facilitate and obfuscate the procurement and sale
    of ACW and WMD to evade legal frameworks and sanctions.
  - Using open-source investigations and data analysis to identify individuals and companies involved in illicit Russian ACW proliferation networks, including connections to offshore networks and corporate secretarial and management providers.
  - Using public records to identify corporate network data and beneficial ownership information related to defense procurement, corruption, and the arms trade.
  - US legal frameworks and international sanctions such as the: Non-SDN Chinese Military-Industrial Complex Companies List (NS-CMIC List), CAATSA-231 (d) List of Specified Persons (LSP), U.S. Department of Commerce's Military End User List and Entity List, Treasury's Specially Designated Nationals and Blocked Persons (SDN) list, and relevant executive orders.
  - Trends and emerging threats related to counterproliferation finance such as cryptocurrencies.
- 3) Experience with virtual events, capacity building programs, teaching, and/or leading trainings for online audiences.
- 4) An understanding of regional political and cultural dynamics in Asia, Middle East North Africa, Sub-Saharan Africa, Eastern Europe, or South America.

- CVs of the SME(s) offered for the project;
