# Seeking Experts on Private Military and Security Companies

#### **Project Summary:**

This project will provide in-depth training on specific open-source tools, a deeper understanding of how prohibited PMCs operate, and access to experts to develop specific strategies to acquire legitimate PMC services without exposure to the negative effects of proliferator state-backed PMCs. The workshops are intended to train participants on how utilizing prohibited PMCs may violate international law, industry standards, and U.S. sanctions prohibitions. Experts will train stakeholders on international best-practices to evaluate, vet, and conduct due diligence during procurement of PMCs by providing actionable, open-source information; in-depth case studies and interactive tabletop exercises related to the deployment, financing, illicit arms transfers, and logistics mechanisms of illicit PMCs.

#### Scope:

CRDF Global is seeking Subject Matter Expert(s) (SME) with expertise related to Russian and Chinese Private Military and Security Companies to lead in-person workshops in Africa and/or South America in 2023 and provide mentorship to grantees following the workshops. CRDF Global will organize:

- Three (3) two-day events in Africa;
- One (1) six-month grant competition
- One (1) two-day event in Latin America

For the upcoming engagements above, CRDF Global is seeking SMEs with expertise and experience working in Africa and/or Latin America. Selected experts will work within a team to:

- develop workshop agendas, curriculum, presentations, interactive activities, table-top exercises and materials, moderate and lead workshop sessions
- travel to and lead in-person workshop engagements
- review submitted grant applications
- conduct participant outreach and recruitment
- provide mentorship via monthly virtual check-ins with selected grantees

#### **Contractor Requirements:**

A successful proposal will highlight **some** of the following qualifications:

- Understanding of international law and best practices on the contracting and operations of PMCs such as the Montreux Document or the International Code of Conduct for Private Security Service Providers;
- Knowledge of the operation of Russian and Chinese-linked PMCs in Africa and/or South America, particularly entities subject to US, EU, or other international sanctions;
- Experience conducting open source investigations to track individuals and institutions involved in PMCs and their related activities;
- Knowledge of case studies showcasing pathways illicit PMCs use to contribute to the arms trade, prolong conflict, infringe on national sovereignty, and create economic dependence.



- Understanding of industry standards for professional PMC operations, and procurement and contracting by states, companies, and/or international organizations;
- Understanding of due diligence and know your customer techniques stakeholders can use to ensure compliance with international sanctions related to PMC-linked activities and entities;
- In-depth knowledge of Russia and China's geo-strategic and geo-economic interests in Africa and Latin America, including specific trends and affected industries and commodities;
- Experience working with audiences such as: oversight and regulatory authorities, national security advisors, election watchdogs, human rights ombudsmen, law enforcement, counterterrorism and counternarcotic units, military representatives, operations managers from the energy and extractives industries, journalists, financial institutions, managers of security personnel and procurement, trade and logistics representatives, humanitarian aid distributers and managers, academics and civil society representatives.
- Experience advising, teaching, leading trainings, or providing mentorship;
- Experience working with stakeholders from Africa and/or Latin America;
- Any foreign language skills, especially Spanish, Portuguese and/or French;
- Flexibility and ability to respond to adjustments directed by the customer;
- Willingness and ability to travel internationally to lead in-person workshops in Africa and/or
  Latin America, if local and CDC guidelines permit it. Due to Covid-19, CRDF Global may postpone
  or rescope the project to entirely virtual engagements which would not require international
  travel. The selected experts would be informed of any changes in advance.
- Willingness and ability to provide mentorship to selected grantees via monthly virtual check in meetings in the local grantee's time zone;
