

CRDF GLOBAL REQUEST FOR PROPOSAL (RFP)

Subject Matter Experts on Enhancing Capacity of Southeast Asian Chemical Distributors to Restrict Terrorist and State Proliferator Access to Online Chemical Sales and E-Commerce

Deadline: March 01, 2023

Summary:

CRDF Global will support one two-day hybrid workshop in Bangkok, Thailand to engage e-commerce policymakers, law enforcement officers and regulators, industry leaders, and other personnel from Singapore, Thailand, Indonesia, Malaysia, Vietnam, and Taiwan. This workshop will improve both regulation and voluntary industry initiatives across sectors in an effort to promote secure purchases and prevent chemicals of concern from being traded online. The workshop will illustrate the risks involved with online chemical weapon supply chains, provide training on the rapidly evolving and disparate typologies employed by these diverse threat actors, and educate participants on risk mitigation strategies. Participants will be equipped with skills to create a more secure online market for chemicals, learn how to identify and prevent e-commerce sanctions violations, and identify chemicals of concern in e-commerce.

Scope of Work:

The subject matter expert (SME) hereby referred to as "The Contractor" will develop course materials for the workshop and present the course materials during the workshop as an SME. The Contractor will be awarded a contract based on the following completion and submission of the tasks and their deliverables outlined below:

Period of Performance: March 15, 2023, through September 18, 2023

Task One: Course Materials Development

The Contractor will contribute to the development of course materials and develop one or more sessions and/or exercises prior to the workshop. The Contractor will coordinate with CRDF Global and other Contractors to ensure the workshop meets CTR's goals. The Contractor should also provide resources for engagement follow-up to continue participant's learning and provide next steps.

Deliverable:

a. One or more presentations, exercises, and/or workshop materials prior to the conference. Submit the presentations, exercises, and/or workshop materials to CRDF Global for review and translation within the time frame agreed upon by the project team.

Level of Effort: Not to exceed 46 hours

Task Two: Travel to Workshop

The Contractor will travel to Bangkok, Thailand to implement the workshop.

Level of Effort: Budget will allocate **24 hours** of roundtrip travel at a 50% pay rate (**12 hours** of travel time in each direction, **not to exceed 8 hours in one day**). See travel support policy for more details.



Task Three: Workshop Implementation

The Contractor will facilitate discussions at the workshop on assigned topics, present their developed presentations and workshop materials, and participate in brief speaker/organization meetings on the day prior to the conference as well as daily at the conclusion of the workshop.

Level of Effort: Budget will allocate 18 hours towards workshop implementation

Task Four: Workshop Close-out

The Contractor will complete and submit to CRDF Global a workshop report summarizing the technical outcomes of the workshop and recommending follow-on activities for to create a more secure online market for chemicals, learn how to identify and prevent e-commerce sanctions violations, and identify chemicals of concern in e-commerce.

Deliverable:

- a. Technical trip report on the workshop implementation and related outcomes, including follow-on activities/recommendations for promoting chemical security in Singapore, Thailand, Indonesia, Malaysia, Vietnam, and Taiwan to be completed and submitted within five days of the workshop end date.
- b. Submit final invoice to CRDF Global within 30 days after workshop is completed.

Level of Effort: Not to exceed 4 hours.

The contractor will have experience developing and delivering workshops on chemical security and additional experience assisting in or leading the chemical security workshops to e-commerce policymakers, law enforcement officers and regulators, and industry leaders. The contractor will have a demonstrated capability to conduct workshops and mentoring in one or more of the following areas:

- Effective government-level policy and response for chemical e-commerce regulations
 - E-commerce sanction evasion
 - Regulatory and voluntary initiatives and legislation to prevent chemical precursor acquisition
 - Supply Chain Security for E-Commerce Markets and Suspicious Transactions
- Customer Due Diligence
 - Verification for suspicious purchases
 - o Know Your Customer techniques in e-commerce
- Dual-Use Chemicals and Equipment for PBA-production
- Pharmaceutical-Based Agents (PBAs) and precursors in East Asia Pacific
- Open-Source Intelligence Tools
 - Search engines for verification
 - Data analysis tools and best practices

Subject Matter Experts shall have:

- 1. Technical Experience: At least 7-10 years of relevant professional experience. Applicable experience can include a combination of the below:
 - Knowledge of chemical security; experience consulting on chemical security best practices and knowledge of key threat actors



- Experience leading workshops targeting international audiences including policymakers, law enforcement officers and regulators, industry leaders
- Experience educating on PBA precursors and dual-use chemicals, as well as their relevance in the e-commerce sector.
- Experience consulting on regulatory and voluntary initiatives to prevent chemical precursor acquisition, as they relate to e-commerce and online chemical sales
- Experience consulting on OSINT/due diligence/KYC topics, as they relate to ecommerce and online chemical sales
- Experience developing and leading interactive exercises regulatory and voluntary initiatives to prevent chemical precursor acquisition as well as OSINT/due diligence/KYC topics

Experience engaging international audiences including policymakers, law enforcement officers and regulators, and/or industry leaders in regions including South Asia, Southeast Asia, Sub-Saharan Africa, Middle East and North Africa, or Latin America
