

CRDF GLOBAL REQUEST FOR PROPOSAL Subject Matter Experts on Curriculum Development for Nigerian University

Deadline: *March* 9th, 2023

Summary:

Terrorist groups such as Boko Haram and ISIS in West Africa continue to perpetrate violent attacks throughout northern Nigeria against government installations and civilian populations and may seek to produce rudimentary CW using dual-use organophosphates originally intended for agricultural use. Northern Nigeria's predominantly agricultural economy relies heavily on fertilizers imported through ports in southern Nigeria. While the Nigerian government has attempted to regulate the agrochemical market, large informal distribution networks, inadequate employee and customer vetting, and vast compliance gaps in the country's chemical transportation sector increase the risk that non-state actors will procure or divert toxic agrochemicals during their distribution to end-users. This project will create a formalized college-level curriculum on chemical security and develop future generations of chemical security advocates in Nigeria.

Scope:

CRDF Global is seeking subject matter experts (SMEs) with experience developing and delivering instructions to university students and faculty on chemical risk management best practices. This engagement will consist of three remote webinars to support 20 Nigerian academics and support their efforts to design a chemical security curriculum on chemical risk management for use by faculty members, students, and staff. The webinar series will identify gaps in current curriculum with short and long-term goals for incorporating chemical security into Nigerian technical curricula and will enable development of short courses on chemical safety and security. The first two webinars are planned to take place in June with a following third Webinar in August/September.

Tasks and Deliverables:

The SME will help develop a chemical security curriculum on chemical risk management best practices company for Nigerian academics and university staff. The SME will be responsible for presenting on chemical security and developing a university curriculum for academics in Nigeria. The first webinar will go over the basics and general overview of chemical security management in Nigeria. The second webinar will go further into dissecting Nigeria; s current chemical security curriculum and identify the gaps and challenges that need to be addressed. Participants will then be trained enough to take this knowledge and share it within there institutions, each representing one of Nigeria's geopolitical zones, and develop their own curriculums to discuss and dissect their findings in the third and last webinar where a single unified security curriculum will be agreed on. The SME will be presenting alongside one local Nigerian SME, and one international SME.

After the webinar series, there will be follow-on mentorship for participants to learn from the Subject Matter Experts further in one-on-one sessions to focus on lessons learned from the webinars, addressing Nigeria's chemical security gaps and challenges. Following these discussions, participants will have a drafted and finalized a national curriculum on chemical security, approved by



the National Universities Commission (NUC) in Nigeria and will be implemented in the participants' respective institutions.

Task One: Project Coordination

The contractor will coordinate with CRDF Global by participating in conference calls, as needed.

Task Two: Training Materials – Agenda and Presentation Development

In coordination with the project team, to include CRDF Global, the Contractor will contribute to the development of a final agenda and up to four presentations covering the topics Dual-Use Chemicals, Chemical Inventory Management Systems, Insider Threats, TTX on Transport and Distribution Securit, and TTX on Know-Your-Customer. The Contractor will coordinate with CRDF Global and other Contractors to ensure the workshop meets CTR's goals.

Task Two Deliverables:

- Set of materials, tailored to a Nigerian audience, to include:
 - Final agenda, to be developed in coordination with project team
 - Up to five (5) presentations

Task Three: Implementation

The contractor will guide participants to identify the gaps in the current chemical security curriculum and how to address these gaps.

Task Three: Implementation

The contractor will lead his portion of the three webinar sessions for up to 20 academics from Nigeria and will attend in full. Each webinar is expected to consist of no more than three hours, focused on providing presentations and answering participants' questions, if needed. The consultant will participate in test sessions lasting 30 minutes prior to each webinar session to ensure video/audio/text capabilities function correctly and will stay online for any extended Q&A and debrief activities for approximately 30 minutes following the end of each session.

Contractor Requirements:

The contractor will have experience developing and delivering trainings on chemical security and additional experience assisting in or leading the chemical security trainings to university students. The Consultant will assist with tasks including, but not limited to the following areas:

- Dual-Use Chemicals
- Chemical Inventory Management Systems
- Insider Threats
- TTX on Transport and Distribution Security
- TTX on Know-Your-Customer
- Review and adapt existing chemical safety and security materials provided by CRDF Global and Sandia National Laboratories (SNL);
- Develop a chemical safety and security training curriculum.
- Implement three webinars to gain university buy-in and raise awareness about the importance of chemical safety and security education among Nigerian academic stakeholders; and



• Present the training curriculum to university stakeholders and the National Universities Commission of Universities (UNC

Subject Matter Experts shall have:

- 1. Technical Experience: At least 7-10 years of relevant professional experience. Applicable experience can include a combination of the below:
 - Chemical security; particularly consulting on university/research laboratory chemical security practices
 - Experience leading training events on chemical security in university/research laboratories
 - Experience developing and leading table-top or interactive exercises on chemical security in university/research laboratories
 - Experience leading or consulting on chemical security in university/research laboratories
 - Experience engaging university students and faculty and/or laboratory staff in regions including South Asia, Southeast Asia, Sub-Saharan Africa, Middle East and North Africa, or Latin America
- 2. Past Performance: Evidence of successful implementation of projects with similar or relevant scopes that were funded by external entities, including non-governmental organizations and international donors. Supporting materials that demonstrate timely communication, completion of tasks, and submission of deliverables should also be referenced.
