

CRDF GLOBAL REQUEST FOR QUOTE

Deadline: June 07, 2024

Summary:

CRDF Global is seeking subject matter experts to support academic and research stakeholders from Brazil, Chile, and Peru in the fields of artificial intelligence (AI) and convergent technologies to enhance institutional research security and IP protection practices via a virtual study tour in August/September 2024 (exact dates to be determined) and remote mentorship.

Scope:

CRDF Global is seeking experts who can authoritatively speak to the importance of mitigating the risk of acquisition of dual-use and sensitive research, intellectual property (IP), and data and provide practical recommendations for adopting best practices in research security and IP protection. Selected experts will engage participants in a virtual study tour and remote mentorship program. The anticipated structure of the virtual sessions includes a series of four, two-hour sessions weekly for a duration of four weeks (eight hours total). The anticipated structure of the remote mentorship is one session per month for a duration of three months following the virtual sessions. A total of nine participants from Brazil, Chile, and Peru will be selected to participate by CRDF Global. Selected participants will receive a grant from CRDF Global to conduct their own local institutional workshop after the virtual sessions.

The topics addressed by the selected experts at the virtual sessions should include two facets of responsible conduct: 1) Exercises and discussions focused on assessing and mitigating the various risks associated with undesired foreign acquisition of relevant dual-use AI research and technologies; and 2) Enhancing the compliance/administrative capabilities of the institutions to include ethics in research, protection of intellectual property from licit and illicit foreign transfer, and internal compliance mechanisms. During the virtual sessions, experts will share case studies of research and talent diversion and best practice frameworks with participants and will examine the utility and opportunities for development and use of these frameworks and practices at the participants' institutions. Participants will receive preliminary material focusing on dual-use technology risk and diversion pathways, to include hands-on exercises with institutional systems to combat acquisition of their research, IP, and data. The experts will engage one-on-one with the participants to promote their ability to inform, raise awareness, and build capacity at their home institutions.

By the end of the virtual study tour and mentorship, the selected experts should have assisted participants with the following:

- Identifying steps they should take to adopt, develop, or enhance processes, policies, and protocols within their institutions for:
 - Student/faculty/researcher, collaborator, donor/investor review/vetting/surety
 - Compliance measures to mitigate risks of institutional and individual participation in foreign talent acquisition initiatives
 - Due diligence on partnerships/collaboration



- Effective processes, policies, procedures to recognize and prevent licit and illicit attempts to transfer dual-use information
- o Communication and coordination with relevant public/security authorities
- Assisting participants to lead effective informational sessions and serve as a resource for counterparts within their institution on foreign research/technology acquisition threats and relevant processes, policies, and protocols to mitigate them

Tasks and Deliverables:

CRDF Global will review all deliverables and may request changes and edits as needed.

- 1. Material for the virtual sessions that includes:
 - a. Agenda: The agenda will encompass the virtual study tour schedule (four two-hour topical sessions) and will be completed in coordination and communication with CRDF Global. The agenda should include the proposed presenter, the session's title, the session's length, and an addendum that provides a brief abstract of each session's purpose and subject matter.
 - b. Presentations on the aforementioned topics in the scope section.
 - c. Outlines and relevant documents/components including case studies and hands-on activities
- 2. Communication in planning calls with CRDF Global on a bi-monthly or ad hoc basis will cover the following:
 - a. Programmatic updates
 - b. Shifts in project implementation
 - c. Recent conversations with the funder
- 3. Present session material and facilitate the virtual sessions
- 4. Conduct remote mentorship sessions for the nine participants
- 5. Completion of a Final Report for which CRDF Global would provide a template
