## 1. BACKGROUND:

CRDF Global, in support of the U.S. Department of State's Office of the Nonproliferation and Disarmament Fund (NDF), will facilitate procurement of equipment and other necessary supplies. CRDF Global will facilitate the shipment of all equipment to Tashkent, Uzbekistan. Considering the critical importance of ensuring chemical safety and enhancing national response capabilities, there is a need to strengthen the material and technical base of the Committee for Industrial, Radiation and Nuclear Safety under the Cabinet of Ministers of the Republic of Uzbekistan. As part of its broader technical assistance efforts, CRDF Global is supporting the Committee in improving the state management and control systems related to industrial, radiation, and nuclear safety. This initiative also seeks to promote regional cooperation and the exchange of international best practices.

To support these goals, CRDF Global is procuring specialized equipment and personal protective gear to enhance preparedness and operational capacity in relevant government institutions.

#### 2. SCOPE OF WORK: Tasks and Deliverables:

#### Task 1: Supply of Equipment

The Contractor shall supply all equipment as listed in Table A, ensuring that each item is brand new, unused, and fully compliant with the specified technical requirements. The Contractor is also responsible for verifying the quality and functionality of the equipment prior to packaging.

### **Deliverables:**

- All equipment listed in Table A, in the required quantity and specifications
- Product datasheets or user manuals (if applicable)
- · Warranty certificates (where applicable)

#### Task 2: Preparation for Pickup

The Contractor shall prepare all equipment for international shipment from the United States to Uzbekistan. This includes packaging and labelling the items in accordance with export and international shipping standards. The Contractor shall coordinate with a third-party logistics provider (assigned by CRDF Global) for pickup from their location and provide the required documentation for customs and transport.

#### **Task 3: Documentation**

The Contractor shall provide all required documentation to accompany the equipment delivery. This includes an invoice, packing list, and other relevant materials to confirm compliance and readiness.

### 3. REQUIREMENTS TO THE OFFER:

- 1. Shall include the comprehensive delivery timelines in calendar days and costs associated for the proposed goods / service.
- 2. Shall specify the duration, scope of warranty and after sales service (if applicable).
