

# CRDF GLOBAL REQUEST FOR PROPOSAL Deadline: October 17, 2025

# **Summary:**

CRDF Global is seeking international security subject matter experts (SMEs) with experience and expertise in arms trade, international security, defense economics and procurement, compliance, and basic knowledge in technical analysis, evaluation and failure diagnostics of weapons systems to participate and present at a two-day regional conference in Buenos Aires, Argentina. SMEs will: a) conduct pre-event research, analyze data and produce a report; b) design, develop and deliver the training content and strategic recommendations to government defense decision-makers, state-owned defense manufacturers, military representatives, and law enforcement stakeholders from South American countries that will address state proliferators' deficiencies in defense production, sustainment gaps, and performance quality of weapons.

# Scope:

The subject matter expert (SME), hereby referred to as "The Contractor" will join a team of 2-3 experts to design and deliver a two-day conference in Buenos Aires, Argentina in January or February 2026 for at least 35 defense and security officials and decision makers across various Latin American Countries. The Contractor will design and deliver tailored sessions and materials on:

- Deceptive marketing and financing practices of defense exporters in proliferator states.
- Poor reliability and battlefield performance of proliferator states' weapons systems.
- **Strategic, political, and economic vulnerabilities** linked to reliance on proliferator states' ACW systems.
- Responsible procurement practices and sanctions compliance frameworks.
- **Regional cooperation models** to safeguard defense acquisition and R&D ecosystems from malign influence.
- Research and analysis on state proliferator arms deficiencies to provide data-driven context for participant decision-making.

## By the end of the conference participants should be able to:

- Demonstrate improved knowledge and understanding of the poor quality and diminished reliability of defense systems of countries.
- Strengthen procurement practices, and act as champions for responsible approaches that reinforce nonproliferation and sanctions frameworks.
- Identify opportunities to collaborate regionally on safeguarding defense R&D and acquisition ecosystems against malign influence.
- Understand defense procurement alternatives available to them.



The selected contractor will be responsible for completing the following tasks and deliverables as part of the contract scope of work:

#### **Tasks and Deliverables:**

## Task One: Development of Conference Agenda and Content

The SME will participate in a virtual kickoff meeting with CRDF Global and ACN/CTR to review the program objectives, target audience, and scope of technical content. The SME will propose draft session outlines and presentation topics aligned with conference goals, incorporating regional context and practical case studies. Following feedback, the SME will refine and submit final agenda contributions.

# Task One Deliverables:

- Draft session outlines and presentation topics within five business days of kickoff meeting.
- Finalized agenda inputs within three business days of receiving feedback.

# Task Two: Research Report on Proliferator States' Weapons Deficiencies

In advance of the development of the training materials, the SME will prepare a research report analyzing deficiencies, sustainment gaps, and battlefield performance limitations of proliferator states' arms, with specific relevance to Latin America. The report (10–15 pages) will be distributed to participants during the conference to reinforce training material and provide a reference resource for decision-making.

## Task Two Deliverables:

- Draft research report (10–15 pages) analyzing proliferator states' weapons deficiencies, sustainment gaps, and battlefield performance limitations.
- Final research report incorporating CRDF Global and ACN/CTR feedback, ready for distribution to participants as a reference resource.

# Task Three: Development of Conference/Training Materials

The SME will then develop training materials to support delivery of the conference, including presentations, case studies, reference handouts, and interactive exercises tailored to the Latin America defense context. Materials should address procurement risks associated with proliferator state's ACW systems, compliance with sanctions frameworks, and strategies for procurement diversification. The SME will also prepare interactive elements such as discussion prompts or exercises to engage participants and design pre- and post-conference survey questions to measure participant learning. Following a round of feedback from CRDF Global and ACN/CTR, the SME will then submit a revised and final set of materials for the conference.

#### Task Three Deliverables:

- Draft training materials package, including PowerPoint slides, case studies, handouts, a pre- and post- workshop survey/test, and reference materials.
- Final training materials package incorporating CRDF Global and ACN/CTR feedback.



# **Task Four: Delivery of Conference Sessions**

The SME will travel to Buenos Aires, Argentina to deliver conference sessions and facilitate discussions in accordance with the finalized agenda. The SME will present technical content, lead interactive exercises, and engage directly with participants during Q&A, networking, and breakout sessions. CRDF Global will provide travel arrangements to/from the conference, including visa, airfare, airport transfers, lodging, per diem based on DoS rates, and travel medical insurance.

## Task Four Deliverables:

- Deliver two-day conference in Buenos Aires, Argentina.
- Contribute to planned roundtable and networking activities to support regional cooperation objectives.

# Task Five: Conference Close-Out, Reporting and Evaluation

The SME will provide written inputs for CRDF Global's After-Action Report (AAR). These inputs will summarize technical observations, participant feedback, knowledge gains, and lessons learned, and will include recommendations for future programming and areas for regional cooperation.

#### Task Five Deliverables:

Submit an after-action and evaluation reports summarizing the technical outcomes, outlining
activity successes, key observations, participant feedback, course feedback, and recommended
areas for future programming within five (5) business days following the conclusion of the
conference.

#### **Contractor Requirements:**

A successful proposal will highlight **some** of the following qualifications:

- In-depth technical knowledge of proliferator states' ACW platforms and their sustainment challenges.
- Experience addressing corruption, malign influence, and vulnerabilities in defense procurement.
- Familiarity with U.S. and international sanctions and nonproliferation frameworks as they relate to defense procurement.
- Regional experience in Latin America, including direct engagement with defense or security institutions.
- Ability to deliver presentations, lead discussions, and provide practical "off-ramping" recommendations for government, military, and law enforcement stakeholders.
- Flexibility and ability to respond to adjustments directed by CRDF Global and/or ACN/CTR.
- Willingness and ability to travel to lead a two-day conference in Buenos Aires, Argentina in late January through the end of February 2026.

- Defense Procurement, Arms Trade & Security Sector Reform
- Defense Systems Knowledge
- Countering Malign Influence & Corruption
- Nonproliferation & Sanctions Frameworks

The contractor should have proven experience working with chemical and pharmaceutical industry or chemical sector actors (e.g. management-level employees, head of sales, security managers, heads of Research && Development and regulators within an industry's regulatory affairs department at pharmaceutical laboratories, manufacturers).

- 11. Marginal (2): Meets some requirements but has deficiencies.
- 12. Unacceptable (1): Fails to meet requirements.
