

CRDF GLOBAL REQUEST FOR PROPOSAL

Deadline: October 30, 2025

Summary:

CRDF Global is seeking subject matter expert(s) (SMEs) with advanced expertise in sanctions compliance, proliferation finance, and counter illicit finance to support the implementation of a project, funded by U.S. State Department's Office of Cooperative Threat Reduction (CTR), that will include a series of sanctions compliance and risk management trainings for financial sector of partner countries. Selected SME(s) will deliver targeted workshops and tailored consultations designed to strengthen the capacity of financial institutions, corporations, and regulatory agencies in high-risk jurisdictions to detect, prevent, and disrupt sanctions evasion activities by state proliferators. Through expert-led presentations, interactive case studies, and facilitated discussions, SMEs will help participants apply sanctions regulations, identify illicit financial flows, and embed compliance mechanisms within institutional frameworks. The project will include ten (10) regional or bilateral one-day workshops and up to forty (40) in-person or virtual one-on-one consultations delivered between January and November 2026. Workshops will draw upon real-world enforcement examples and typologies of sanctions evasion linked to Russia's war in Ukraine and PRC proliferation financing schemes. The project will also incorporate trade data and/or sanctions screening tools, with access provided to participants as part of CTR-funded capacity-building support.

Scope:

The Contractor will join a team of subject matter experts to deliver up to ten (10) in-person one-day workshops across priority partner countries for at least 300 total (approximately 30 participants per training) representatives from financial institutions, corporations, and regulatory bodies on detecting and disrupting sanctions evasion by state proliferators and boosting risk management practices in partner countries in Europe and Asia. Trainings will focus on strengthening compliance frameworks, enhancing financial and trade due diligence, and integrating sanctions detection methodologies to prevent illicit financial and supply chain activity supporting WMD programs. In addition, the SME will provide up to forty (40) targeted in-person or virtual one-on-one consultations with select institutions to apply workshop concepts, review internal compliance processes, and improve sanctions enforcement practices in line with U.S. and international regulations.

Tasks and Deliverables:

CRDF Global is seeking SME(s) that can implement the entire project or specific components of the deliverables that best align with the SME(s)' expertise and past experience.

CRDF Global will consider proposals from both individual experts and institutional teams capable of supporting the following tasks and deliverables:

- 1. Aid in the identification of and communication with key stakeholders, including financial institutions, regulatory bodies, and compliance associations, throughout the project term (12 months);
- 2. Develop content for and deliver up to ten (10) one-day regional and bilateral workshops across priority partner countries in Europe and Asia to train approximately 300 total participants (around 30 per training) on detecting and disrupting sanctions evasion by state proliferators, strengthening risk management, KYC/KYCC practices;
- 3. Provide up to forty (40) one-on-one virtual or in-person consultations with financial institutions, corporations, and regulators to strengthen sanctions compliance frameworks, enhance risk-based monitoring, and apply best practices tailored to local jurisdictions (*Note: in-person consultations will take place only following in-person workshops and will not require standalone international trips to locations of financial institutions*);



- 4. Attend bi-weekly and ad-hoc coordination calls as needed through the end of the project period (no later than December 2026);
- 5. Submit an After Action Report summarizing workshop outcomes, key observations, successes, lessons learned, and recommendations for future programming to support sustained sanctions enforcement capacity.

Contractor Requirements:

At least five years of relevant experience conducting research, delivering briefings or trainings, and/or implementing policy or capacity-building activities related to sanctions enforcement, counterproliferation finance, or illicit network disruption involving state.

Knowledge of the following subject matter areas:

- 1. Methods used by state proliferators and associated entities to facilitate and conceal sanctions evasion through complex corporate structures, offshore jurisdictions, trade intermediaries, and third-party enablers.
- 2. Application of financial intelligence, trade data analysis, and sanctions screening tools to identify evasion networks, front companies, and proliferation financing activities linked to proliferator states' defense-industrial base and illicit dual-use technology procurement.
- 3. Use of corporate registries, beneficial ownership data, and trade or maritime records to trace high-risk actors and transactions connected to sanctioned entities.
- 4. U.S. and international legal frameworks governing sanctions and export controls, including authorities under Executive Orders 14024 and 14114, the U.S. Department of Commerce's Entity List, Treasury's Specially Designated Nationals (SDN) List, and related EU/UK sanctions mechanisms.
- 5. Trends and emerging threats related to proliferator states' sanctions evasion activities, including typologies in financial, logistics, maritime, and energy sectors.
- 6. Experience working with or advising Financial Intelligence Units (FIUs), AML/CFT bodies, export control agencies, law enforcement, or compliance officers to strengthen institutional risk management and enforcement capacity.
- 7. Familiarity with suspicious transaction reporting, sanctions screening processes, and compliance systems within financial and corporate sectors.
- 8. Familiarity with developing and maintaining correspondent banking relationships.
- 8. Experience developing and sustaining public-private partnerships and peer networks to enhance sanctions compliance collaboration.
- 9. Demonstrated experience conducting both in-person and virtual capacity-building workshops and trainings for international audiences.
- 10. Familiarity with trade data platforms, sanctions screening software, and analytical tools used to detect high-risk transactions or entities.
- 11. SMEs who do not currently have access to trade data or sanctions screening tools are still encouraged to submit proposals, as CRDF Global will provide CTR-funded licenses for use during the project.

- 11. Marginal (2): Meets some requirements but has deficiencies.
- 12. Unacceptable (1): Fails to meet requirements.

Basis for Award:

The award will be made to the offeror whose proposal provides the best value to the government, considering both technical and price factors. The government reserves the right to make an award to other than the lowest-priced offeror if a higher-priced offeror demonstrates superior technical capabilities.
