### **REQUEST FOR PROPOSALS**

#### **Building Networks Among Women to Share Best Practices and Experience Working in Nuclear Security and Nonproliferation Fellowship**

**Deadline: June 15, 2026**

#### **Summary:**

CRDF Global, in partnership with Global Affairs Canada under the Weapons Threat Reduction Program (WTRP), is launching an eight-month fellowship to strengthen the role of women in nuclear security and nonproliferation globally. This fellowship supports the implementation of United Nations Security Council Resolution (UNSCR) 1540, fostering inclusive, rights-based societies where all individuals, regardless of gender, can fully participate in economic, political, social, and cultural life.

The fellowship will select six pairs of female-identifying professionals from South Asia, the Middle East, Africa, Latin America, and Southeast Asia, including scientists, government representatives, academics, and nuclear security practitioners. Each pair will participate in a three-part program designed to build technical expertise, leadership skills, and professional networks:

1. **Five-Part Webinar Series (July 2026):** This virtual training series will equip fellows with the skills and knowledge to design and implement their mini-grant projects effectively. Sessions will cover nuclear security and nonproliferation principles, UNSCR 1540 implementation, project management, proposal writing, monitoring and evaluation, research and policy development, networking, and fundraising. Fellows will also receive guidance on integrating open-source tools, geospatial analysis, and nuclear risk reduction methods into their projects. Each pair will be assigned to a regional mentor who provides individualized feedback and facilitates connections with the broader nuclear security community.
2. **Mini-Grant Project Implementation (July 2026 – February 2027):** Following the webinar series, each pair will implement a joint mini-grant project (up to \$8,000 USD) that strengthens networks among women in nuclear security and nonproliferation within their home institutions. Projects should promote women's leadership and participation in decision-making, address institutional and structural barriers to inclusion, and include clear strategies for knowledge dissemination beyond direct participants. SMEs and mentors will provide ongoing guidance, including technical input, support for scalable interventions (mentorship programs, workshops, training sessions, surveys), and assistance in monitoring and evaluating measurable outcomes.
3. **Capstone In-Person Workshop (February 2027, Vienna, Austria):** The program culminates in a two-day workshop where fellows present project outcomes, share lessons learned, and explore collaborative opportunities for scaling impact. Activities include roundtable discussions on policy and gender equality, tabletop exercises leveraging technology for nuclear risk reduction, and site visits to the International Atomic Energy

Agency (IAEA) to engage with female professionals in the field. SMEs will facilitate technical sessions, provide feedback, and support networking opportunities to further enhance leadership, skills, and global professional connections.

Through these components, the fellowship cultivates a sustainable, cross-regional network of women professionals equipped to advance inclusive approaches to nuclear security and nonproliferation, strengthen technical expertise, and promote gender equity in leadership roles.

CRDF Global seeks Subject Matter Experts (SMEs) to provide technical guidance, mentorship, and professional support across all three program components. SMEs will play a key role in enhancing fellows' capacity to design and implement impactful projects while building a global network of women leaders in nuclear security.

### **Scope of work (SOW):**

The SME will support the fellowship by strengthening participants' technical knowledge, professional skills, and leadership in nuclear security and nonproliferation. SMEs will provide technical guidance, mentorship, and facilitation support across all fellowship components, working closely with CRDF Global staff, regional mentors, and fellows. Their contributions will help ensure strong project design, measurable outcomes, and sustainable professional networks for women in nuclear security globally.

SMEs are expected to engage in one, two, or all three fellowship components (development and delivery of virtual webinar(s), mentoring a pair(s) of fellows, and developing and delivering in-person training at the capstone workshop) and contribute to strengthening technical expertise, leadership development, and the long-term impact of fellows' mini-grant projects.

### Core Responsibilities

- Provide technical expertise on nuclear security, nonproliferation, and UNSCR 1540
- Mentor fellows on project design, implementation, evaluation, and sustainability
- Support development of monitoring and evaluation tools to measure impact
- Contribute to webinars, discussions, and capstone workshop activities
- Promote gender-inclusive leadership and women's participation in nuclear security
- Provide written inputs, feedback, and documentation of lessons learned
- Coordinate closely with CRDF Global and regional mentors throughout the program

### **Tasks and Deliverables:**

#### Task 1: Webinar Series Support (July 2026)

SMEs will support a five-part virtual webinar series, two hours each (one or several webinars) by delivering technical content, facilitating discussions, and guiding fellows in developing their mini-grant projects.

#### Deliverables:

- Deliver expert-led webinars on nuclear security, nonproliferation, and UNSCR 1540
- Participating in Q&A and post-webinar discussions with fellows

- Submit proposed topics for the five webinar sessions with application/RFP

### Task 2: Mini-Grant Project Mentorship (July 2026 – February 2027)

SMEs will mentor assigned pair(s) of fellows virtually over an eight-month period, providing ongoing technical guidance and feedback as they implement their projects.

#### Deliverables:

- Provide guidance on project design, methodology, budgeting, and execution
- Review and provide written feedback on project plans and progress updates
- Support development of monitoring and evaluation tools (metrics and data collection)
- Advice on dissemination strategies and sustainability of project outcomes
- Connect fellows with relevant regional networks and technical resources

### Task 3: Capstone In-Person Workshop Support (February 2027, Vienna, Austria)

SMEs will support the final capstone in-person two-days workshop (CRDF Global will arrange all travel and logistics), where fellows present outcomes and participate in technical and professional development activities.

#### Deliverables:

- Identify training topics for the capstone in-person workshop and submit with proposal
- Develop and deliver technical sessions and tabletop exercises on nuclear risk reduction
- Write workshop evaluation and SME report outlining observations, recommendations, and challenges
- Participate in networking activities, including site visits (e.g., IAEA)

### **Qualifications and Selection Criteria (SME/Mentor Contractor)**

SMEs may apply for all tasks or select specific components based on their expertise, interest, and availability (e.g., full or partial webinar facilitation, mentoring one or multiple grantee pairs, and/or capstone in-person workshop participation).

#### Required Qualifications

- Demonstrated expertise in nuclear security, nonproliferation, or related fields, including UNSCR 1540
- Experience designing and delivering virtual and in-person technical training or webinars
- Experience mentoring or training women in STEM, leadership, or nuclear security contexts
- Experience in project design, implementation, and monitoring and evaluation
- Professional proficiency in English
- Availability for virtual engagement in July 2026 and in-person participation in Vienna, Austria, February 2027

### Professional Experience and Skills

- Background in nuclear security, policy, research, or related technical fields
- Experience supporting training programs, workshops, or professional development initiatives
- Ability to provide structured technical guidance and produce written outputs
- Strong cross-cultural communication and collaboration skills
- Experience working in international or multi-regional contexts
- Ability to commit to all program phases (webinars, mentorship, and capstone workshop)
- Demonstrated reliability and ability to meet deliverables on time
- Commitment to gender-inclusive leadership and professional development

- SMEs and mentors will be compensated according to negotiated agreements based on experience and contribution.
- Travel, lodging, and per diem for the Vienna workshop will be fully covered by CRDF Global.

## **Contractor Selection Criteria:**

CRDF Global will select SME contractor(s) that provide the best value in terms of relevant technical expertise, experience, proposed approach, and cost (if applicable). Applicants should demonstrate strong experience in nuclear security, nonproliferation, and UNSCR 1540, as well as the ability to deliver technical training (virtual and/or in-person) and provide mentorship to professionals, particularly women in STEM and nuclear security fields. Experience supporting project design, implementation, and monitoring and evaluation, as well as familiarity with international and cross-regional contexts, will be considered advantageous.

CRDF Global prioritizes a safe and collaborative work environment in which diversity, equity, and inclusion are championed and actively promoted. CRDF Global provides equal opportunity to all qualified individuals without regard to age, race, color, religion, sex, sexual orientation, gender identity, national origin, protected veteran status, or disability status. We are committed to fostering a respectful, inclusive, and engaging environment and promoting diverse participation and representation across all program activities.

## **Selection Criteria and Evaluation Methods:**

### Evaluation Factors

1. Technical Approach – Relevance and alignment of the proposed methods with the fellowship objectives, including mentoring, webinar support, mini-grant guidance, and capstone workshop contributions. Feasibility, clarity, and inclusion of proposed webinar topics and draft workshop agenda will be considered.
2. Key Personnel and Qualifications – Expertise in nuclear security, nonproliferation, and UNSCR 1540; experience mentoring women professionals in technical or STEM fields; facilitation, leadership, and cross-cultural skills; familiarity with international organizations (e.g., IAEA, WINS).
3. Management Approach – Clear plan for engagement across all program phases, including coordination with CRDF Global staff and regional mentors, mentoring methodology, progress monitoring, and deliverable quality assurance.
4. Cost/Price – Reasonableness and clarity of proposed cost relative to scope of work and program objectives.
5. Risk Management – Identification of potential challenges (e.g., scheduling, virtual engagement) and strategies to mitigate them.
6. Small Business Participation (if applicable) – Use of small businesses or partnerships where relevant.

### Evaluation Methods

Proposals will be evaluated using one of the following methods, as determined appropriate by CRDF Global:

7. Lowest Price, Technically Acceptable (LPTA): Selection of the lowest-cost proposal that meets all technical requirements.
8. Best Value Trade-Off: Selection based on the best combination of technical merit, experience, and cost to achieve fellowship objectives.

The award will be made to the proposal that demonstrates the strongest overall alignment with fellowship objectives, technical expertise, experience, feasibility, and cost-effectiveness, ensuring high-quality SME support across all program phases.

Evaluation Scoring Methodology:

Proposals will be evaluated based on the following scoring system:

9. Excellent (5): Exceeds all requirements and offers superior benefits.
10. Good (4): Meets all requirements with some additional value.
11. Acceptable (3): Meets all minimum requirements.
12. Marginal (2): Meets some requirements but has deficiencies.
13. Unacceptable (1): Fails to meet requirements.

**Basis for Award:**

The award will be made to the offeror(s) whose proposal(s) represent the best value to CRDF Global and GAC, considering technical merit, relevant experience, and cost (if applicable). Proposals will be evaluated based on the SME's demonstrated expertise in nuclear security, nonproliferation, and UNSCR 1540; experience delivering virtual and/or in-person technical training; and ability to mentor and support professional development, particularly for women in STEM and nuclear security fields. Consideration will also be given to the quality, relevance, and feasibility of the proposed approach to webinars, mentorship, and/or capstone workshop contributions, as well as the SME's qualifications, availability, and ability to contribute across one or more fellowship components. Familiarity with international and cross-regional contexts, including engagement with organizations such as the IAEA or WINS, will be considered an asset. Cost reasonableness and overall value for money will be assessed in relation to the proposed scope of engagement, and CRDF Global may select one or multiple SMEs based on program needs.
